Sec. 171.01. There is hereby created the Ohio retirement study commission COUNCIL of fourteen members as follows:

(A) Three members of the senate, appointed by the president of the senate, not more than two of whom may be members of the same political party:

(B) Three members of the house of representatives, appointed by the speaker of the house of representatives, not more than two of whom may

be members of the same political party;

(C) Three members appointed by the governor, with the advice and consent of the senate, not more than two of whom shall be members of the same political party, one of whom shall represent the state and its employees; one of whom shall represent nonstate governments and their employees; one of whom shall represent educational employers and their employees. Terms of the existing members appointed by the governor shall not be affected. Terms of office of members appointed by the governor shall be for three years, commencing on the first day of July and ending on the thirtieth day of June. Each member appointed by the governor shall hold office from the date of his appointment until the end of the term for which

he THE APPOINTMENT was appointed MADE. Any member appointed by the governor to fill a vacancy occurring prior to the expiration of the term for which his THE MEMBER'S predecessor was appointed shall hold office for the remainder of such term. Any member shall continue in office subsequent to the expiration date of his THE MEMBER'S term until his THE MEMBER'S successor takes office, or until a perod PERIOD of sixty days has elapsed, whichever occurs first.

(D) Five ex officio members as follows: the executive director of the public employees retirement system, the executive director of the state teachers retirement system, the executive director of the school employ ees retirement system, the executive secretary of the police and firemen's disability and pension fund, and the secretary of the state highway patrol retirement board, who shall be nonvoting members.

A vacancy on the commission COUNCIL shall be filled by the person qualified to make the original appointment for the unexpired term, in the same manner as the original appointment.

The members of the commission COUNCIL who are appointed from the membership of the senate and the house of representatives shall serve during their terms as members of the general assembly and until their successors are appointed and qualified, notwithstanding the adjournment of the general assembly of which they are members or the expiration of their terms as members of such general assembly.



SECTION 27. The following agencies shall be retained pursuant to division (D) of section 101.84 of the Revised Code and shall expire on December 31, 2001, pursuant to the version of section 101.84 of the Re-

vised Code that takes effect on January 1, 1997, with the exception of the Muskingum River Advisory Board which shall expire on June 29, 1998, pursuant to Section 2 of Am. H. B. 351 of the 117th General Assembly:
