(A) ON AND AFTER THE FIRST DAY OF THE MONTH FOLLOWING THE EFFECTIVE DATE OF THIS SECTION, EACH PERSON ELIGIBLE TO RECEIVE AN AL-LOWANCE, PENSION, OR BENEFIT, PURSUANT TO SEC-TIONS 3309.35, 3309.36, 3309.38, 3309.40, DIVISION (A) OF SEC-TION 3309.45, AND SECTION 3309.46 OF THE REVISED CODE THAT WAS BASED UPON AN AWARD MADE EFFECTIVE BEFORE JUNE 30, 1955, SHALL HAVE THE ALLOWANCE, PENSION, OR BENEFIT PAYABLE AS OF SEPTEMBER 30, 1974. RECALCULATED BY THE SCHOOL EMPLOYEES RE-TIREMENT BOARD SO THAT EACH SUCH PERSON SHALL RECEIVE AN ANNUAL SINGLE LIFETIME ALLOWANCE, PENSION.
