#### Deduction for group health insurance.

Sec. 742.45. Any member of the fund who on the date of his retirement, is participating in a group health insurance plan, the premiums for which are deducted from his salary, may, by filing a written notice with the board of trustees of the police and firemen's disability and pension fund, on forms provided by the board, elect to have said premiums deducted from his monthly pension or disability check and paid by the board if said health insurance plan provides that he may continue to participate therein after his retirement. On the filing of said notice, the board shall make such deductions from the member's monthly pension or disability benefit and shall pay said premium accordingly. Any member who files such a notice with the board shall be deemed to consent to the deductions made and shall receipt in full for his monthly pension or disability benefit, and payment less said deductions shall be a complete discharge and acquittance of all claims and demands by such member during the period covered by such payment. (*Enacted in Amended House Bill No. 642*)

#### Right to benefit or pension.

Sec. 742.46. The granting of a benefit or pension to any person under sections 742.01 to 742.49, inclusive, of the Revised Code, vests a right in such person to obtain and receive the amount of such benefit or pension granted to him subject to sections 742.01 to 742.49, inclusive, of the Revised Code.

Such right may be enforced by an action in mandamus instituted in the court of common pleas in the county in which the person granted such benefit or pension resides. (*Enacted in Amended House Bill No. 642*)

#### Status of sums of money due or to become due.

Sec. 742.47. Sums of money due or to become due to any person from the police and firemen's disability and pension fund are not liable to attachment, levy, or seizure under any legal or equitable process, whether such sums remain with the treasurer of the fund or any officer or agent of the board of trustees of the fund, or is in the course of transmission to the person entitled thereto, but shall inure wholly to the benefit of such person. (*Enacted in Amended House Bill No. 642*)

#### Notice of waiver.

Sec. 742.48. Any person who is receiving, or becomes eligible

to receive, a pension, or under 742. of the Revised thereto, or to a portion with the board of trustees and pension fund. Such first day of the month written cancellation of the police and firemen's so waived shall forever (*Bill No. 642*)
