SECTION 4 (SEC. 145.491). Notwithstanding any provision of Chapter 145. of the Revised Code, the public employees retirement system shall be authorized to calculate the employee and employer contribution rates separately for those employees electing to receive benefits under ~~divisions~~ DIVISION (B) or (C) of section 145.33 of the Revised Code.
