Sec. 742.03. (A) As used in this section and in sections 742.04 and 42.05 of the Revised Code
(1) "Police officer" means a member of the fund who is an employee of police department and is not a police retirant.
(2) "Firefighter" means a member of the fund who is an employee of a fre department and is not a firefighter retirant.
(3) "Firefighter retirant" means a member of the fund who is receiving an age and service or disability benefit as a result of service in a fire department or a surviving spouse of a deceased member who is receiving a benefit as a result of the deceased member's service in a fire department.
(4) "Police retirant" means a member of the fund who is receiving an (4) Police retirant" means a member of the fund who is receiving and department or a surviving spouse of a deceased member who is receiving a benefit as a result of the deceased member's service in a police department.
(B) The administration, control, and management of the police and iremen's disability and pension fund, created under section 742.02 of the Revised Code, is vested in a board of trustees of the police and firemen's disability and pension fund, which shall consist of nine members as follows:
(1) The attorney general
2) The auditor of state;
(3) The fiscal officer of a municipal corporation who shall be appointed by the governor. This member's term shall be for three years, commencing on the fourth day of June and ending on the third day of June. The fiscal officer member shall hold office from the date of his appointment until the end of the term for which te appointed. Any fiscal officer member appointed to fill a vacancy occurring prior to the expiration of the term for which THE FISCAL OFFICER MEMBER'S predecessor was ap pointed shall hold office for the remainder of such term. Any fiscal officer member shall continue in office subsequent to the expiration date of his THE FISCAL OFFICER MEMBER'S term until his SUCH MEMBER'S successor takes office, or until a period of sixty days has elapsed, whichever occurs first.
(4)

Two employee members shall be police officers elected by police officers. Two employee members shall be firefighters elected by firefighters. The fifth employe member perition ohatl be held in altemating terme by a poliee effeer eleeted by poliee effieme and by a firefighter eleeted by frefiger Employee members of the board shall be elected for terms of four years as provided by section 742.04 of the Revised Code.
(5) One member known as the retirant frember whe ohall be a reaident of this state. The retirant member persition mhat be held in alternating termo by $a$ firefighter retirant elected by firefighter retirante and $a$ poliee retirant elected by poliee retiranto. The retirant member of the board ehath be eled for a term of four years provided by seetion 748.04 of the Reviged Gode. ONE MEMBER KNOWN AS THE FIREFIGHTER RETIRANT MEMBER, WHO SHALL BE A RESIDENT OF THIS STATE ELECTED BY THE FIREFIGHTER RETIRANTS. THE FIREFIGHTER RETIRANT MEMBER SHALL BE ELECTED FOR A TERM OF FOUR YEARS AS PROVIDED BY SECTION 742.04 OF THE REVISED CODE.
(6) ONE MEMBER KNOWN AS THE POLICE RETIRANT MEMBER, WHO SHALL BE A RESIDENT OF THIS STATE ELECTED BY THE POLICE RETIRANTS. THE POLICE RETIRANT MEMBER SHALL BE ELECTED FOR A TERM OF FOUR YEARS AS PROVIDED BY SECTION 742.04 OF THE REVISED CODE.
(C) No employee member of the board who retires while a member of the board shall be eligible to become a retirant member for three years after the date of the member's retirement.
